NOTIFICATION

**of establishment of the fact of entering information on a foreign citizen
to the register of controlled persons**

When registering foreign citizen ¹ _____

at the place of his/her stay (check-in at Artel 17/52 Hotel)

the managing organization - ARTEL MANAGEMENT Limited Liability Company (hereinafter - WONE Hotels)

in accordance with the requirements of Federal Law No. 115-FZ dated July 25, 2002 "On the Legal Status of Foreign Citizens in the Russian Federation" (hereinafter - Law No. 115-FZ) and the Rules for Migration Registration of Foreign Citizens and Stateless Persons in the Russian Federation, approved by Decree of the Government of the Russian Federation dated January 15, 2007 No. 9,

carried out the mandatory check of the availability (absence) of information on a foreign citizen in the Register of Controlled Entities,

following the results thereof **reliable information was obtained on inclusion in the specified register.**

According to subparagraph 9 of paragraph 2 of Article 31.1 of Federal Law No. 115-FZ, a restrictive measure is applied in respect of a controlled person in the form of a prohibition for change of the place of residence or place of stay in the Russian Federation without the permit of the territorial body of the federal executive authority in the field of internal affairs, exercising control.

Due to the established circumstances, in order to specify your migration status and possible restrictions, ARTEL MANAGEMENT recommends that you **should immediately contact the supervisory authority**, the Migration Department of the Directorate of the Ministry of Internal Affairs of Russia for the Vasileostrovsky district of St. Petersburg (address: 12a, 19th line of Vasileostrovsky district, 199026 St. Petersburg, phone: 8 (812) 573-37-46).

Taking into account the provisions of the applicable legislation of the Russian Federation, ARTEL MANAGEMENT draws your attention to the right to refuse in check-in at Artel 17/52 Hotel to a person entered in the register of controlled entities.

By signing this notification, you confirm the proper and understandable explanation of ARTEL MANAGEMENT on the absence of legal grounds for your stay (residence) in the Russian Federation, the obligation to immediately contact the supervisory authority, and also agree that the refusal in check in (if applied by ARTEL MANAGEMENT) does not discriminate, does not affect your personal qualities, and is a necessary measure due to the requirements of the legislation of the Russian Federation in the field of migration control, as a result of which it cannot be considered improper fulfillment of obligations by ARTEL MANAGEMENT Company (Artel 17/52 Hotel).
